- c.) The bank balance has been verified but the balances are not tallied with the pass book of the current year and Reconciliation for the same has been provided by the management.

Part-II: JANBHAGIDARI SAMITI

- a.) We have audited Janbhagidari Samiti cashbooks. The cashbooks are -properly maintained. The bank balance has been verified but the balances are not tallied with the pass book of the current year and Reconciliation for the same has been provided by the management.
- b.) The amount received in Janbhagidari Samiti cashbook has been verified and are free from any material discrepancy.
- c.) Reconciliation entry of the previous year entered in cash book during the year as per bank reconciliation statement provided.

Part -III: NSS, NCC, RED RIBBON AND VISHVAVIDHAYALAYA

- a.) The college is receiving amount from Vikram University for the event organization the excess balance left with college after organizing the event will be refunded the same to Vikram University. And in case of shortage, college itself beared the same.
- b.) The details of amount received and expenses done have been taken as provided by the management.

- b.) The amount remained after utilizing the balance of grant if is returned back to the appropriate authority.
